Location

The property is located off Marston Road on Villiers Trading Estate, just off the A449 Penn Road, a main arterial route serving Wolverhampton City Centre. Alternative access is also offered by way of Sunbeam Street. The property forms part of a long established industrial estate with a variety of local and national operators. Nearby occupiers include Tesco, Screwfix, KFC and Jardine motor dealership.

Description

The mid terrace property is of portal frame construction with full height brick elevations, north light roof with internal insulation. The main access is off Sunbeam Street via an electric roller shutter and single personnel door with a further pedestrian access to the rear via a shared service yard off Marston Road. The unit is predominantly open plan with a brick built mezzanine and staff area to the wetern elevation and W.C. block. The unit benefits from an eaves height of 5.4m, sodium and LED lighting and a floor mounted gas blow heater, externally there is parking for approximately 8 vehicles in an enclosed and shared yard off Sunbeam Street.

N.B - The current occupiers also occupy the adjoining unit (Unit 5) and have made an opening in the dividing wall one bays width.
